The program is accredited by the Commission on Collegiate Nursing Education.</p>
MINIMUM QUALIFICATIONS:	<p>The successful candidate will have a doctorate, preferably a Ph.D., in nursing science or a closely related area (applicants who are ABD will be considered if their dissertation will be complete by August 1, 2015), have an M.S. in Nursing, be eligible for licensure as a Registered Nurse in Illinois, and have national certification and work experience as a Family Nurse Practitioner or Adult-Gerontology Nurse Practitioner.</p>
PREFERRED QUALIFICATIONS:	<p>Those candidates who have the successful university-level teaching experience and a proven ability to conduct research and secure external funding will be given preference.</p>
