The position may also include graduate-level teaching.</p> <p>The nursing program offers a B.S. in Nursing through pre-licensure and degree-completion programs, and an M.S. in Nursing with specializations in Family Nurse Practitioner and Nurse Educator. The program is accredited by the Commission on Collegiate Nursing Education.</p>
<b>MINIMUM QUALIFICATIONS:</b>	<p>The successful candidate will have a doctorate, preferably a Ph.D. in nursing science or a closely related area (applicants who are ABD will be considered if their dissertation will be complete by January 15, 2017), have a master's degree or higher with a major in nursing, at least five years of clinical nursing leadership experience at the director level or higher, be eligible for licensure as a Registered Nurse in Illinois, and have demonstrated experience in nursing course development, either didactic or online</p>
<b>PREFERRED QUALIFICATIONS:</b>	<p>Those candidates who have the successful university-level teaching experience, a proven ability to conduct research and secure external funding and possess a nursing management certificate will be given preference.</p>
