	The Graduate Nursing Internship Coordinator is an academic administrator who reports to the Director of Graduate Studies and assists the Director and the Chair with general administration of the graduate nursing program. The responsibilities of the Coordinator include, but are not limited to, coordinating internship experiences for graduate nursing students, recruiting preceptors, managing internship distribution among nursing specialties, and ensuring the timely progression of all graduate students.
	The NIU School of Nursing offers a B.S. in Nursing through pre-licensure and degree-completion options, an M.S. in Nursing with specializations in Family Nurse Practitioner and Nurse Educator, and a Doctor of Nursing Practice (DNP). The program is accredited by the Commission on Collegiate Nursing Education.
MINIMUM QUALIFICATIONS:	The successful candidate will have a Master's degree in nursing and eight or more years of nursing clinical experience and two or more years of experience as a nurse educator in academic and/or clinical settings.
PREFERRED QUALIFICATIONS:	Those candidates who have excellent communication and organizational skills, a working knowledge of university academic policies, nursing program administration and familiarity with healthcare informatics, will be given preference.
