Old Business Review Draft Board of Nursing Annual Survey Report Presentation: Stephanie Gedzyk-Nieman, MSN, RNC-MNN, Assistant Professor Lewis University, College of Nursing and Health Professions, and Doctorate of Nursing Practice student.</p> <p>The Illinois Department of Financial and Professional Regulation/IDFPR Board of Nursing collects information on an annual basis from all Illinois pre-licensure nursing education programs. Disclosure of this annual mandatory report is required to maintain Board of Nursing pre-licensure nursing education program approval, which is required for a nursing student to be eligible to take the nursing license examination; the response rate is 100 per cent (NPA Rules 1300.230 and 1300.340).</p> <p>Background (M. Bromberg) : the report complies and reviews data from 2011-2015, the survey process and its content was standardized and includes the National Forum of State Nursing Workforce Centers Minimum Dataset for education (http://nursingworkforcecenters.org/) and will be presented to the Board of Nursing at their November meeting. The report is aimed at health planners.</p> <p>Overview (S. Gedzyk-Nieman): the report has essentially three separate sections after background: programs, students and faculty; each section briefly reviewed.</p> <p>Discussion: key points presented should be the executive summary; there are Implications for policy and planning are.</p> <p>Regional data: this report will only have state level data, suggest to include in report that this does not include regional data and that there may be significant variances.</p> <p>Implications: what are the implications of the annual number of students completing education programs in light of the number of nurses planning on retiring; include the data from the RN and LPN relicensure survey reports, what is anticipated in the next ten or so years; suggest to review annually.</p> <p>There needs to be a balance proportion of experienced nurses and proportion of new graduate nurses for the safety of a unit, define experience as between two to five years, there is a commitment to safety.</p> <p>New roles, such as care coordination, discharge planning, and new areas of work, for example, in the past 80% of nurses worked in hospitals, now it is 60%; the roles, discharge planning, but to hospital administrators; is some association in past 80% nurses work in hospitals, now 60%; how to message to both nursing and non-nursing communities the value of nursing.</p>	<p>Plan: recommendations will be made prior to presentation to the Board of Nursing in November.</p>

This incorporates the nursing perspective on boards – the nursing lens</p> <p>3. There are a variety of reports submitted to Robert Wood Johnson Foundation/Center to Champion Nursing in America on behalf of the state action coalition/IHAC; for example twice a year as a state action coalition, separate quarterly reports as a culture of health participant, and monthly calls with W. Quinn</p> <p>4. The Public Health Nurse Leaders Workgroup pilot project, the goal of which is to increase the number of public or community health sites for undergraduate students is moving forward.
