| <p>IV. Reports</p> <p>1. Chairperson’s report, C. Hovanec:</p> <p>a. Transitioning foreign educated nurses to Illinois nursing license: initial meeting was on Friday, April 28, 2017. Representatives from Philippine Nurses Association Illinois, NAHN-IL, Indian Nurses Association IL, Chicago Bilingual Nurses Association, International Polish Nurses Association, M. Bromberg attended representing the Board of Nursing.</p> <p>There was a roundtable discussion of resources, barriers, regulatory differences amongst states for licensure, nursing education variances amongst different countries, M. Bromberg spoke a lot about the Enhanced Nursing Compact and the potential impact for Illinois as well as answering other licensure questions. The group was able to touch a bit on how nurses in the community and in nurses’ associations work to support and transition foreign educated nurses to IL licensure.</p> <hr/> <p>2. ICN Manager report, LBRoberts</p> <p>a. Robert Wood Johnson Foundation Public Health Nurse Leaders – covered under announcements</p> <p>b. National Forum of State Nursing Workforce Centers annual meeting, June 6-9,, Denver, Colorado. Illinois participated as part of a panel “Collecting State Level Nursing Supply Data: Sharing Strategies”: Iowa, Illinois & Washington. The majority of state workforce centers create or are involved in nursing workforce reports. Next annual meeting June 20-22, 2018, Embassy Suites Chicago-O’Hare-Rosemont: conference theme: “P4: Policy, Practice, Populations, Possibilities”. Illinois along with other Midwest states are part of the planning committee for this meeting. Executive Director’s meeting: continued funding of workforce centers remains an issue, most are seeing a decrease in funding</p> <p>c. Outreach includes recent articles in <i>Nursing Voice</i>: http://www.ana-illinois.org/</p> <hr/> <p>3. Nursing Coordinator, M. Bromberg</p> <p>a. NCSBN: enhanced multi-state compact- need 26 states to pass legislation to enact the enhanced compact by 2018; thus far 22 states have received legislative approval. In July there is a tri-regulators meeting: pharmacy, nursing medicine.</p> <p>b. Legislation: HB0313 is a comprehensive bill, includes language to amend the Illinois Nurses Practice Act, which sunsets Dec 31, 2017. The bill has passed one chamber,</p> | |
