IL RN Continuing Education Pre-Approved Sponsor Information

The rules set forth a larger number of organizations that are considered “pre-approved” sponsors. These organizations do not have to obtain a CE sponsor license from IDFPFR but must still comply with the standards and requirements regarding content, certificates, etc. Below is a partial list of pre-approved sponsors.

If the sponsor is listed in the section below, then the courses may be used for IL RN relicensure in 2021. Each licensee is responsible for maintaining records of completion of continuing education and shall be prepared to produce the records if requested by the Department.

NURSE PRACTICE ACT, SECTION 1300.130 CONTINUING EDUCATION

c) Approved CE Sponsors and Programs

1) Sponsor, as used in this Section, shall mean:

- A) Approved providers of recognized certification bodies as outlined in Section 1300.400(a).
- B) Any conference that provides approved Continuing Medical Education (CME) as authorized by the Illinois Medical Practice Act.
- C) American Nurses Credentialing Center (ANCC) accredited or approved providers.
- D) Illinois Society for Advanced Practice Nursing (ISAPN).
- E) American College of Nurse Practitioners.
- F) American Academy of Nurse Practitioners.
- G) Nurse Practitioner Association for Continuing Education (NPACE).
- H) American Association of Nurse Anesthetists.
 - I) National Association of Clinical Nurse Specialists (NACNS).
 - J) American College of Nurse Midwives.
- K) Illinois Nurses Association or its affiliates
- L) Providers approved by another state's board of nursing
- M) Any other professional association established prior to 2007 and approved by the Division upon recommendation of the Board, that provides CE in a form and manner consistent with this Section.
- N) Nursing education programs approved under Section 1300.230 or 1300.340 wishing to offer CE courses or programs.
- O) Employers licensed under the Hospital Licensing Act [210 ILCS 85] or the Ambulatory Surgical Treatment Center Act [210 ILCS5].
- P) Any other accredited school, college or university, or State agency that provides CE in a form & manner consistent with this Section.

Please note that this is not a complete list. See Section 1300.130(c) (1) for additional groups or entities. In addition, organizations may obtain CE sponsor licenses issued by the Department.

Again, all licensees are urged to review Section 1300.130 of the Nurse Act Rules for additional detailed information.
