Illinois Nursing Workforce Center, June 4, 2024, Appendix A FY24 Nurse Educator Fellow Individual Abstracts

The Illinois Nursing Workforce Center and the Illinois Board of Higher Education (IBHE) collaborated once again this year for recognizing the recipients of the IBHE Nurse Educator Fellowships. This year's class of 76 honorees represent Nursing education programs at 42 different institutions of higher education with accredited nursing programs leading to initial licensure as a Registered Nurse. These nursing programs are at public community colleges and universities, and non-profit and for-profit independent colleges and universities throughout the state of Illinois.

The Nurse Educator Fellowship program is designed to retain well-qualified nursing faculty in Illinois with a salary supplement to be used for the faculty member's professional development, scholarship or other endeavors as nurse educators to improve the preparation of future nurses. Fellows are selected through a competitive process and two rounds of applications were accepted in fiscal year 2024 to allow greater access to the Fellowship program. From both rounds of awarding fellowships, there was some attrition due to changes in applicants' employment and one sponsoring private university for two Fellows officially closed in the spring semester. Each Fellow received a \$10,000 salary supplement for a grand total of \$760,00 awarded in fellowships. The number of fellowships awarded nearly doubled from the previous fiscal year due to an increase in funds in Governor JB Pritzker's fiscal year 2024 budget supported by the Illinois General Assembly.

The Illinois Nursing Workforce Center Advisory Board (INWC) and the Illinois Board of Higher Education (IBHE) celebrated the recognition of the 76 IBHE Nurse Educator Fellows at three virtual lunch-and-learn events this summer. The showcasing of the 2024 Nurse Educator Fellows began during the Illinois Nursing Workforce Center's Advisory Board meeting on June 4th, 2024. Additional recognition events were June 12th and July 11th, 2024. Across the three recognition events,14 team presentations were given by Fellows that highlighted how they are using the fellowship funds for professional development and to enhance nursing education. These team presentations were organized by common experiences such as simulation training; leadership development; diversity, equity and inclusion training; advanced degree programs and certifications; new curriculum, teaching, and research; and professional conferences. In addition to the team presentations, each Fellow is also required to submit a 200 to 250-word abstract describing the fellowship experience.

The Nurse Educator Fellowship Award from the Illinois Board of Higher Education (IBHE) will be immensely valuable for me as I progress as a nurse educator role impacting nursing students in their diversity, inclusion, and cultural sensitivity. I currently teach full-time at Illinois State University's Mennonite College of Nursing as an assistant professor. Comparing nursing specialty areas in clinical practice, salaries for nurse educators are relatively modest. This grant will specifically support my ongoing effort and dedication to teach nursing students about diversity and cultural sensitivity. Using my expertise in transcultural nursing, my nursing students will gain valuable insights from my instruction on Latino culture and the Spanish language. In 2022, the Latino

population in the USA was around 62.1 million or 18.7% of the total population. There are approximately 2.2 million Latinos residing in Illinois or about 17% of the population. These Latino and Spanish-speaking populations in Illinois will require culturally competent nurses. Using my expertise in transcultural nursing, my nursing students will gain valuable insights from my instruction on Latino culture and the Spanish language. My goal with the funds from the IBHE scholar program is to implement different teaching and learning strategies to help my students to develop their clinical reasoning skills by using virtual reality as a simulation game activity. Today's nursing students need different ways to learn to meet their diverse learning needs and to be actively involved in their own learning and to embrace technology. Virtual reality is an effective pedagogy for nursing students that is safe and engages students in the learning process (Salminen-Tuomaala et al, 2018; Salminen-Toumaala, 2023). I plan to use virtual simulation in all my clinical courses and especially the internship course. In the internship course I will develop a multiple patient scenario where the student starts off with one patient and then works up to a full team of four to five patients. The simulation game software replicates clinical reasoning processes in real world situations (Salminen-Toumaala, 2023). The game elements will be built around the process of clinical reasoning. The student will have to recognize cues, analyze cues, process information to formulate nursing diagnosis, identify problems, plan nursing interventions, and evaluate outcomes for each patient. I would like to purchase virtual reality headsets to use for the gaming simulation. The students will access the virtual reality

headsets within our simulation center at flexible times that students are on campus. I also plan to take the Certified Nurse Educator Exam.

Therefore, investing in the education and retention of nurse educators is essential to sustain the nursing workforce and ensure high-quality patient care in the future.
