IDFPR news release on 5/20/15; AP picked up release on 5/26/15 resulting in requests for interviews from ABC-7 TV, WSIL-3 TV; national distribution through Modern Healthcare News and the daily ANA SmartBrief. Next steps with RN data: additional journal publication and consider develop workforce policy recommendations. LPN 2013 workforce survey: data collection complete 1/31/15, response rate 21/7% approximately 6,600 responses. Short review of questions and results that include approximately 48% of LPNs work in long-term care facilities; about 30% of all LPNs are planning on retiring in the next few years. For FY2015 LPN data evaluation is not funded. Next steps with LPN data: seek clarification with getting further data analysis; create document itemizing questions that are difficult to answer without this data evaluation; request meeting with Secretary Schneider, Director Stewart and ICN Chairperson to discuss this and funding other ICN projects. c. Update Academic Progression (D. Meyer)

Institute of Medicine meeting: 5 year Evaluation of the Future of Nursing: Campaign for Action. D. Meyer presented on behalf of AOADN/American Organization of Associate Degree Nursing education programs. She was on a panel focusing on education, various programs, transitions, etc

Discussion included how many community colleges not accredited. Data, the nursing community is on track to increase the number of doctoral prepared RNs by 2020, primarily due to the DNP; the number of RNs with a baccalaureate has only increase 49-51%.

This evaluation committee's report is due 12/2015; this committee cannot change the original IOM recommendations from 2010.

There is an emerging model from New Mexico being considered by Lewis and Clark Community College and Southern Illinois University-Edwardsville.
