<p>V. Old Business Data Workgroup: Licensed Practical Nurse/LPN Workforce Survey Report 2015, Draft #6: the ICN Data Workgroup report including Executive Summary. Recommended changes: demographic charts – include totals for each category, in addition to the specific age ranges. A few editorial typos were identified. M/S/V: C. Haviley move, M. Lebold second: to approve LPN 2015 Workforce Survey Report. The ICN Data Workgroup is commended. Funding for IHAC website has been pre-paid to include 2016 and 2017. b) RWJF Campaign for Action Summit Dec 2015, Washington, DC. 5 year progress report: we have made progress, we have more to do. There is interest in sustainability, focus continues education, leadership, practicing at the top of the scope, diversity and improving the culture of health.
