Illinois Nursing Workforce Center Manager Report</p> <ul style="list-style-type: none"> • Data collection is complete for the voluntary individual post-license renewal surveys. LPN license renewal was complete on January 31, 2021. Current focus RN data analysis and report. • The annual Board of Nursing mandatory pre-licensure nursing education survey, which included COVID-19 pandemic impact questions – discuss New Business. <ul style="list-style-type: none"> • National Forum of State Nursing Workforce Centers (National Forum): an article entitled: <i>The Impact and Effects of COVID-19 on the Nursing Pipeline and Workforce</i>, has been submitted for publication. Board of Nursing: their next meeting is in March 5, 2021. <ol style="list-style-type: none"> 1. Meetings continue to include proposals for new pre-licensure nursing programs. 2. The annual 2020 NCLEX® pass rates are available and will be discussed at the next March board meeting. Pass rates will available on the Nursing Workforce Center website this week. ii. National Council State Board of Nursing (NCSBN) <ol style="list-style-type: none"> 1. The 2021 meetings will continue to be remote/virtual. 2. There continue to be scams, for example if a state website lists a licensee on probation, the licensee is contacted and told to pay a fee and threatened to seize license if fee is not paid immediately. iii. Legislation: the legislature is meeting today. A few bills were discussed: <ol style="list-style-type: none"> 1. HB73: to have all six City of Chicago community colleges include a pre-licensure school of nursing program on each campus. In 2014 the schools combined the nursing programs onto Malcolm X campus. 2. HB580: Nursing Licensure Compact (NLC). There are currently 34 states that are members of the NLC. Discussion: if Illinois was a member of the NLC it would have facilitated the recruitment of nurses at the beginning of the COVID-19 pandemic. 3. HB309: all healthcare professionals to be required to complete continuing education on strategies to reduce bias 4. SB105: APRN legislation regarding physician attestation of previous practice during initial APRN-FPA application

<p>IV. Old Business</p> <p>a. RN 2020 voluntary individual license renewal data draft comparisons. Six data comparison tables reviewed. Discussion:</p> <ol style="list-style-type: none"> 1. Who is the target audience? The audience has included legislators, the public, possible funders of nursing, as well as nurses and other healthcare professionals. 2. Plan: to create initial report targeting the public. Data tables, graphs to support the issues identified in the key findings/talking points. Include focus on nursing faculty, aging and retiring. Consider a survey of only nursing faculty, FT, PT and adjunct. Would need to access faculty at pre-licensure, baccalaureate complete and graduate nursing education programs. Include what is changing in healthcare, heat maps of the number of nurses per county. 	
<p>V. New Business</p> <p>a. Nursing Workforce Center pre-licensure school of nursing COVID-19 survey summary results reviewed. Data was collected between September and December 2020, most responses received in September and October, 2020. Discussion:</p> <ol style="list-style-type: none"> 1. How has pre-licensure nursing education changed during the COVID-19 pandemic? Changes include: most clinical sites allow less students per site than they have in the past. This requires more adjunct faculty to be at different clinical sites with students. Many programs have purchased additional simulation equipment and simulation programs. Programs continue with virtual or remote didactic. 2. Plan: COVID-19 pandemic questions to include with 2021 Board of Nursing annual pre-licensure school survey: costs: keep the question re: PPE; add questions about: additional adjunct faculty, additional preceptors; additional simulation equipment and programs; COVID-19 testing requirements; COVID-19 vaccination requirements; mental health services for faculty; mental health services for students; adequacy of mental health services. <p>b. Resilience project with Illinois Health and Hospital Association (IHA), Illinois Organization of Nurse Leaders (IONL) and ANA-Illinois. Discussion: review of background information, draft questions and resource information for potential participants. Surveys to be self-administered by each organization.</p>
