Review the documents from 2019, including priorities as per statute and subsequent goals, objectives. Also briefly review HB1615 legislation, and Logic Model of strategic planning documents. Will have strategic planning added to each future agenda. 2019 was the most recent year the INWC completed a strategic plan, prior to the 2020 COVID-19 pandemic.
