# **VII.Reports**

- a. Chairperson Report, K. Jones
  - i.A Nursing Workforce Center FY23 project, webinars highlighting where nurses can receive graduate education in Illinois preparing them to become nursing faculty, is completed. The webinars were conducted this past fiscal year in October, December 2022 and February, March, and April 2023. Each hourlong webinar program that was presented and taped is now available on IDFPR YouTube page https://www.youtube.com/@IDFPRmedia.
  - ii. This fall there is a planned project, in partnership with the National Council of State Boards of Nursing (NCSBN): providing Next Generation NCLEX® (NGN) examination webinars for Illinois pre-licensure nursing faculty. We anticipate that these two 60–90-minute lunch-and-learn webinars, one for LPN faculty, one for RN faculty, will be held in October 2023.
  - iii.(From the Nursing Organization Update section below) the Public Health Nurse Leaders (PHNL) Workgroup information below; end of grant reports are being collected by the Illinois Nurses Foundation (INF). The PHNL nurse leaders have scheduled a remote planning meeting June 20, 2023.
  - b. Illinois Nursing Workforce Center Manager Report, LB Roberts
    - i.National Forum State Nursing Workforce Centers annual meeting, announcements.
    - ii.Outreach activities: April 18, Student nurse political action day, Springfield, IL. The day-long event was in-person, first time since 2019. There were 24 programs approximately 500 students attended. Business cards with QA code distributed, approx. 900 cards to students and to nursing faculty, who sometimes took 50-100 cards for future distribution.
      - April 28, Nurses Fair, Rockford, IL area: sent IDFPR pamphlets, and business cards with DPR QA code which were distributed from an information table.
      - Future events: will have details when confirmed.

#### iii. Other:

-Review IDFPR board member travel guidelines that were distributed and placed in SharePoint Online earlier this week. Review the purpose of the travel voucher is to make claim for reimbursement for travel expenses incurred while traveling to/from required board meetings and/or events. Since board meetings begin at 10-11am it is anticipated that use of hotel rooms will not be needed on a routine basis. Review of covered expenses and details page-by-page. Questions asked and answered.

- No new HFS information, on the multi-year project that has a focus on the healthcare workforce, various licensed professions. Continue communication and anticipate future meetings
- ISAC Nursing Education Scholarship Program (NESP) scholarship: annual application submission ended April 30, 2023; this is the first year that ISAC coordinated all scholarship activities. There were 1, 216 applications submitted, the incomplete applications have a May 31, 2023, completion deadline.
- IDFPR Continuing Education (CE) license renewal FAQ sheets with the new 1-hour implicit bias awareness training requirement for LPNs, RNs and APRNs have been posted on the INWC website, tab: Nursing Licensure, subtab: Continuing Education.
- RWJF: there is a remote meeting with state representatives during the National Forum of State Nursing Workforce Centers annual June meeting.
- c. Nursing Organization updates
  - i.The Public Health Nurse Leaders Workgroup (PHNL) update: RWJF/Robert Wood Johnson Foundation PHNL grants: the INF continues to collect the end of grant reports. All grant funds were distributed in December 2022. There were six grants distributed, 2 reports are received; 2 are outstanding and 2 are due FY24.
  - ii.Illinois Nurses Foundation (INF): weblink shared for current raffle ticket fundraiser.
  - iii.Illinois Coalition of Nursing Organizations (ICNO): most recent meeting Fall 2022.
- d. Nursing Coordinator Report, M. Bromberg
  - i. Illinois Board of Nursing
  - -The pre-licensure RN & LPN annual pass rates for 2022 have been posted on the IDFPR website. The categories of schools with less than standard pass rates reviewed. Schools also receive remediation guidelines that have been created by the Illinois Board of Nursing/BON and are nationally recognized.
  - During the 5/5/23 Illinois Board of Nursing Advisory Board meeting: all 16 schools that are on probation presented their remediation plans. Eleven schools that just went on probation will have a site visit conducted in May. The schools that received a warning letter will present their plan of correction at the July 7, 2023, Illinois Board of Nursing meeting.
- ii. Legislative update
- HB559: this has been sent to the Governor, it is not yet enacted. Since 3/20/20 IDFPR has issued temporary practice permit (TPP) reinstatements and endorsements to certain healthcare professionals, including nurses. All TPP holders may continue to practice if they apply for licensure by endorsement to the Department on or before May 11, 2023. Any such person may continue to practice under their temporary out-of-state permit until the license is issued or the application is denied, at which time the temporary out-of-state permit shall expire. If the license application is not decided by May 11, 2024, the temporary out-of-state permit shall expire. The same terms apply to the temporary reinstatement permit. This applies to licensed professions, including RNs, LPNs, and APRNs.



# Appendix A FY23 Nurse Educator Fellows Abstracts and Survey Results May 2023

The Illinois Nursing Workforce Center Advisory Board (INWC) and the Illinois Board of Higher Education (IBHE) recognized the Fiscal Year 2022 Nurse Educator Fellows during the Nursing Workforce Center's advisory board meeting May 10, 2023. Each Fellow received a \$10,000 salary supplement and presented verbal remarks on the use or the intended use of the award for professional development activities. Forty educators from twenty-six institutions in FY23 and were awarded the Fellowships through the Illinois Board of Higher Education (IBHE) Nurse Educator Fellowship Recognition program.

The Illinois Board of Higher Education maintains strong support of the Nurse Educator Fellowship. Nominee contracts were verified prior to award recognition. IBHE began notifying recipients in December 2022, recognition was announced at the January 18, 2023, IBHE board meeting. This was followed by completion of contracts and distribution of funds. Many Nurse Faculty Fellows used the funds for professional development between receipt of recognition and the end of June 2023. 100% of survey respondents agreed that receipt of funds would impact achievement of intended goals.

The FY23 Nurse Educator Fellows completed a short online survey regarding the Fellowship. There are 40 Fellows, 40 responses. This is a summary of responses. All of the respondents continue to be employed in nursing education at the institution that nominated them for this recognition, this is a Fellowship requirement which has been verified with the institution. Thirty-six or 90% of the respondents are employed as faculty, four or 10% have a dual role as administrator and faculty member.



As shown in the chart, the majority (85%/34) of Fellows responded that they plan to use the award to attend conferences or other educational events. Thirtythree percent (13) responded that they would use the award to help pay for tuition; 20% (8) will use funds for skills acquisition. Thirty-eight percent (15) answered that the award would be used toward a special project, some of which are listed below. Forty-three percent (17) indicated that funds would be used to acquire certification (such as Certified

Nurse Educator). Please note that respondents could choose more than one answer, so the percentage totals are more than 100%.

The Fellows were asked if the recognition made any changes to their practice as nurse educators including special projects and equipment purchased. The comments on projects are also described in the abstracts. Individual comments about changes to their practice were primarily implementing information, lessons learned from a conference or research into practice; some included learning and incorporating NCSBN Next Gen tools into teaching students; exposing to more opportunities; support of research for DNP degree; support of lifelong learning.

The final question, how educating nurses post COVID-19 pandemic might change, consistently elicited comments in a few areas: a flexibility of teaching modalities developed during the pandemic is now standard; clinical settings have broadened to include more non acute care, community settings; include lessons in prevention, equity and advocacy; include resilience, educating students re: self-care. A few comments:

- Educating nurses throughout covid has been challenging, but I do believe that it has taught
  our students that health care is constantly changing and as nurses, we have to adapt,
  sometimes in a very short time frame. Going forward, I do feel we are going to need to
  intently focus on bringing clinical into the classroom to further develop the clinical
  judgement skills of our students.
- Educators must be flexible in teaching modalities and meet the students where they are. Education changed dramatically during the COVID-19 pandemic, and we need to recognize that by being innovative and diverse.
- We need to exemplify post-pandemic teachings and lessons learned in prevention, equity and advocacy as the pandemic brought forth many of these needs.
- Covid-19 has had a profound impact on healthcare and nursing. It is essential that nursing
  educators properly prepare new graduate nurses to promote competence, confidence, and
  retention. Implementation of dedicated education units through academic practice
  partnerships is a valid method of providing clinical experience to nursing students and
  ensuring that they are applying theory to practice. This clinical experience will improve
  clinical judgement, critical thinking, and assist in their role transition.
- Education post-pandemic calls for immersive and experiential learning experiences. This
  will improve active learning among learners and prepare nursing students for clinical
  practice.
- I believe that Covid opened the possibility of educating online and in a technological world.
   I believe nursing education may migrate to more electronic learning environments such as VSim and VR. I also see some classes moving online. This is a result of how Covid provided the opportunity to continue learning in various online environments, but also due to the nursing shortage as a result of Covid and the need to provide nursing education not more students.
- Educating the next generation nurses requires programs that align with NCLEX® Next
  Generation and faculty creating more interactive classrooms. Students want more than
  just lecture in coming to class. The pandemic has given easy access to students with online
  lectures, and students feel if they are commuting, they should be able to have an
  experience that helps them to learn.
- Two recent surveys, one from New Jersey and one from Michigan, provided valuable data on the challenges that nurses in the field are facing on a daily basis. Nursing education should use this data to change the way we prepare our new graduate nurses. It is more than just teaching clinical judgement and skills, we must teach resiliency!
- The COVID-19 pandemic has changed many things, including nursing education. It has caused nursing students to be more tech savvy than previously. It took away opportunities for clinical rotations, which means that nursing instructors have had to work twice as hard to be creative and bring clinical into the classroom. With a lack of clinical rotations, there's a lack of critical thinking and nursing judgment. On the bright side, I believe that the pandemic has allowed nurse educators to stray away from tradition lecture, and to bring in more hands-on activities.

I think nearly everything has changed n how we educate nurses in the post-COVID-19 era. From the topics we tech to how we teach (the methods), we are now more accustomed to instant access to knowledge and perhaps lesser prioritization of critical thinking. I believe that the change that is touted as "post-COVID-19" were changes already in the making but catalyzed by the constraints of the pandemic and acceleration of other areas, such as technology dependence. I don't know if this question can be answered fully here, but my simplest answer is to say that educating nurses post-COVID-19 pandemic HAS changed and remained changed forever.

These survey responses indicate that the Fellowship is achieving its intended goals, i.e., to help institutions retain their well-qualified nurse educators to educate and train nursing students so that Illinois can continue to address the long-term demand for registered professional nurses.

Growing up, I always knew I wanted to be in education. I plan to use the IBHE funds to continue career coaching that I began in 2021. Career coaching is tailored for women of color in academic medicine. Coaching was a key turning point in my career when I made a mind shift that led to NIH R01 funding and renewed my commitment to a career in academia. Without this IBHE award I will not be able to continue coaching sessions which for me, is a form of self-care. In addition, to using the funds for self-care I am also able to participate in Restorative Justice and Circle training. Restorative Justice training will help me learn how to facilitate circles to promote: 1)inclusive decision making, 2)active accountability, 3) repairing harm, and 4) rebuilding trust. Grounding student engagement, connectivity, and problem solving in these principles helps support student development. Thank you for your commitment to retain nurses in Illinois.
